Minutes of Town Board Special Meeting: Nov. 18, 2014

The Town Board of the Town of Rensselaerville held a Special Meeting on the 18th day of November, 2014 at 6:30 in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Lounsbury and the roll was called with the following results:

PRESENT WERE: Supervisor Valerie Lounsbury, Councilman Robert Bolte, Councilwoman Margaret Sedlmeir, Councilman Gerald Wood, Councilwoman Marion Cooke, Town Clerk Victoria H. Kraker There were two interested citizens present as well as Highway Superintendent Randy Bates.

The purpose of the Special Meeting was to adopt the 2015 Budget and to address any other matters before the Board.

Supervisor Lounsbury stated that she believes the budget is at a point where it is ready to be passed with a 1.3% increase.

Marie Dermody pointed out an error in Central Print and Mailing: the 'change' column should be \$500 not \$5,000. Supervisor Lounsbury thanked Mrs. Dermody for noticing the typographical error.

A motion was made by Councilwoman Sedlmeir to adopt the 2015 budget; 2nd by Councilman Bolte. Motion carried: Ayes (5) Lounsbury, Bolte, Sedlmeir, Wood, and Cooke; Nays (0)

Supervisor Lounsbury checked into whether or not the Town would have to repeal the Tax Cap Law in order for residents to receive the tax credit. It does in fact need to be repealed. She has spoken to the attorney for the Town and he will draw up the revised Local Law. It can be passed at the December meeting as it does not need to be completed until January 21, 2015 when Supervisor Lounsbury certifies that the Town was under the tax cap and the Local Law was repealed.

A motion was made by Councilwoman Cooke to repeal Local Law No. 1: the Tax Cap Override; 2nd by Councilman Wood. Motion carried: Ayes (5) Lounsbury, Bolte, Sedlmeir, Wood, and Cooke; Nays (0)

TRANSFERS: Councilwoman Cooke had questions regarding the billing for the Town of Rensselaer-ville compared to other Towns. Councilman Bolte questioned whether or not the Town could reduce its number of polling locations in order to reduce costs. Supervisor Lounsbury will make some phone calls to find the answers to these questions.

A motion was made by Councilwoman Cooke to pay the Board of Elections bill, based upon confirmation of the accuracy of the billing; 2nd by Councilwoman Sedlmeir. Motion carried: Ayes (5) Lounsbury, Bolte, Sedlmeir, Wood, and Cooke; Nays (0)

laerville.

The purpose of this law is to continue an existing one-year moratorium, set forth in Local Law No.3 of 2011 of the Town of Rensselaerville and renewed again in Local Law No. 2 of 2012 and in Local Law No. 2 of 2013, to temporarily suspend the administrative review, approval process and/or drilling activities associated with the production of natural gas on lands located in the Town of Rensselaerville for either new or pending proposals or activities regarding gas drilling. Pursuant to the statutory powers vested in the Town of Rensselaerville to regulate and control land use and to protect the health, safety and welfare of its residents, the Town Board of the Town of Rensselaerville hereby declares an additional one-year moratorium on the drilling for or extraction of natural gas within that subterranean area known as the Marcellus Shale or any other shale deposits located on or under land in the Town of Rensselaerville by the process commonly known as high-volume hydraulic fracturing.

Public Comments:

Supervisor Lounsbury read an email from John Mormile as follows:

"I understand that on November 18, the Town Board will hold its hearing on extending the town's fracking moratorium. Unfortunately, I am away all week, so I will not be able to attend the meeting. However, I will be there is spirit. I urge the Board to extend the moratorium so that a potential ban on fracking and all heavy industry in our township can be discussed in connection with the total, proposed zoning law changes. I thank you and the Board members for your consideration in this matter.

Sincerely, John Mormile"

<u>Jeannette Rice</u>: thanked the Board for the opportunity and for bringing the moratorium up for a vote once again. Speaking for both herself and her husband, she hopes the Board will pass this law again so that the Town can have the necessary safeguards in place to protect the Town's sense of space, land, clean air, water, and rural way of living. She thanks the Board again for their consideration.

<u>Georgette Koenig</u> would like to see the moratorium made permanent. She is very worried about the water. She also noted that violations are only \$100/day. That is nothing to a gas company and she feels that amount would not deter them if they really wanted to come in. She asked if that amount could be increased. Supervisor Lounsbury stated she would check into that.

RESOLUTION OF THE TOWN OF RENSSELAERVILLE TOWN BOARD

WHEREAS, the Town Board is in receipt of the proposed local law provided by the New York State Department of Environmental Conservation ("DEC") by letter dated September 18, 2014, which proposed local law incorporates the regulations required to maintain the Town's eligibility in the National Flood Insurance Program; and

WHEREAS, it is the desire of the Town Board to adopt the proposed local law provided by the DEC; and

WHEREAS, attached hereto is the proposed local law provided by the DEC, with the information requested by the DEC incorporated therein;

NEW THEREFORE, BE IT RESOLVED by the duly convened Town Board of the Town of Rensselaerville, Albany County, New York, that (1) the Attorney for the Town is authorized to forward to the DEC for its review the attached proposed local law; and (2) pursuant to the Municipal Home Rule Law and the General Municipal Law, a public hearing shall be conducted at the Town Hall on February 10, 2015 on the attached proposed Local Law, and notice of the time and place of such hearing shall be published on or before January 28, 2015 in a newspaper circulating in the Town.

2. Attorney Fallati read a Resolution which also needs to be adopted and presented to the DEC along with the above as follows:

RESOLUTION TO APPLY TO PARTICIPATE IN THE NATIONAL FLOOD INSURANCE PROGRAM

WHEREAS, certain areas of the Town of Rensselaerville are subject to periodic flooding and flood-related erosion, causing serious damages to properties within these areas; and

WHEREAS, relief is available in the form of federally subsidized flood insurance as authorized by the National Flood Insurance Act of 1968; and

WHEREAS, it is the intent of the Town Board of the Town of Rensselaerville to require the recognition and evaluation of flood or flood-related erosion hazards in all official actions relating to land use in areas having these hazards; and

WHEREAS, this body has the legal authority to adopt land use and control measures to reduce future flood losses pursuant to the New York State constitution, Article IX, Section 2, and Environmental Conservation Law, Article 36;

NOW THEREFORE, BE IT RESOLVED, that this Town Board hereby:

- 1. Assures the Federal Emergency Management Agency that it will enact as necessary, and maintain in force for those areas having flood or flood-related erosion hazards, adequate land use and control measures with effective enforcement provisions, including:
- a. Require permits for all proposed construction or other development in the community so that it may determine whether such construction or other development is proposed within the floodplain.
- b. Review proposed development to assure that all necessary permits have been received from those governmental agencies from which approval is required by Federal or State law.
- c. Review and maintain all permit applications to determine whether proposed building sites will be reasonably safe from flooding.
- d. Review and maintain all permit applications to ensure that any development activities are consistent with criteria set forth in Section 60.3 of the National Flood Insurance Program Regulations.
- 2. Vests the Town Building Inspector with the responsibility, authority, and means to:
- a. Assist the Administrator, at his/her request, in the delineation of the limits of the area having special flood or flood-related erosion hazards.
- b. Provide such information as the Administrator may request concerning present uses and occupancy of the floodplain or flood-related erosion areas.
- c. Cooperate with federal, state and local agencies and private firms which undertake to study, survey, map, and identify floodplain of flood-related erosion areas, and cooperate with neighboring communities with respect to management of adjoining floodplain and/or flood-related erosion areas in order to prevent aggravation or existing hazards.
- d. Submit on the anniversary date of the community's initial eligibility an annual report to the Administrator on the progress made during the past year within the community in the development

and implementation of floodplain management measures.

- e. Upon occurrence, notify the Administrator, in writing, whenever the boundaries of the community have been modified by annexation or the community has otherwise assumed or no longer has authority to adopt and enforce floodplain management regulations for a particular area. In order that all Flood Hazard Boundary Rate Maps accurately represent the community's boundaries, include with such notification a copy of a map of the community suitable for reproduction, clearly delineating the new corporate limits or new area for which the community has assumed or relinquished floodplain management regulatory authority.
- f. Ensure that the community's Flood Insurance Rate Maps are maintained and kept current by providing the Federal Emergency Management Agency with any new or updated flood risk data or any modified data reflecting natural or man-made changes to the floodplain
- 3. Appoints the Town Building Inspector to maintain for public inspection and to furnish [upon] request, for the determination of applicable flood insurance risk premium rates within all areas having special flood hazards identified on a Flood Hazard Boundary Map or Flood Insurance Rate Map, any certificates of flood-proofing, and information on the elevation (in relation to mean sea level) of the level of the lowest floor (including basement) of all new or substantially improved structures, and include whether or not such structures contain a basement, and if the structure has been flood proofed the elevation (in relation to mean sea level) to which the structure was flood proofed.
- 4. Agrees to take such other official action as may be reasonably necessary to carry out the objectives of the program.

HIGHWAY DEPARTMENT

- 1. Highway Superintendent Bates reported that so far this year, approximately 36 inches of snow has fallen in the higher elevations and the Town has used close to 700 tons of salt/sand mix.
- 2. During a typical winter the highway responds to approximately 30 snow and/or ice events. Thus far, they are up to response number 15.
 - 3. The trucks are in good shape overall.
- 4. There are many hanging and downed trees. The highway men are carrying chainsaws in their trucks, cutting their way through some areas, and hope to get to the major clean-up soon.
- 5. Superintendent Bates is looking at a truck that is available on-line from Greene County. It is an Oshkosh and would be used for parts.

CODE ENFORCEMENT OFFICER/BUILDING INSPECTOR:

- 1. Code Enforcement Officer/Building Inspector Overbaugh reported one Home Replacement and one Home Addition for the month of November. He is continuing with inspections and following through on Certificates of Occupancy and Certificates of Compliance.
- 2. Officer Overbaugh wanted to bring to the Town's attention a barn on Smith's Corners that he suspects is about to collapse into the road. The way the 'unsafe building' law is written, the process to file a complaint must be commenced by someone who owns property within 1000 feet of the structure. Only after that filing can any action be taken. In the alternative, Officer Overbaugh will try to locate the owner to see if a resolution can be found.

ASSESSORS:

- 2. The Assessors are preparing to send renewal notices for the tax exemptions. Those exemption renewals must be returned to the Assessor's Office by March 1, 2015. They would also like to remind residents that anyone who will be 65 years of age by December 31, 2015 should apply for the Enhanced Star Exemption.
 - 3. Assessors Tollner and Wank are on the budget committee for Greenville Central School.
- 4. Assessor Tollner has completed all coursework for certification and Assessor Wank continues to work on hers.

- 2. Shutting the water off to the Rensselaerville Park proved to be helpful in locating a major leak. The daily treated water is now down to between 16,000 and 18,000 gallons/day.
 - 3. Any further investigations and/or repairs will have to wait for the weather to moderate.







COLD WEATHER IS HERE

Old Man Winter is almost here and we all know what that means: Snow...Cold...loe...BRRR. Here are some tips to stay safe and warm until spring.

Winter Driving Snow and ice can be a common theme during the winter time months. Be sure to keep an eye on the sky _ and the roadways. Dropping temperatures mean that wet roads may turn to ice quickly. Heavy snow fall can make roads impassable and high winds can cause snow drifts in open areas. Keep items like phone charger, flashlight, and blankets in your vehicle in the event that you get stuck and are temporarily stranded. Be mindful in poor weather conditions. If the weather is really bad, please stay home if at all possible.

Vehicle Safety Don't be lazy. Shovel the snow off the car before driving it. Excess snow on the vehicle can blow onto the windshield causing poor visibility, slide off the roof and block the wipers, or blow off causing the motorist behind to panic. Make sure tire tread is suitable for winter driving. Brush snow away from head lights and tail lights to ensure the best visibility.

Home Safety Winter means snow removal around the home. Shoveling, snow blowing, and plowing. Please keep walkways clear in the event of an emergency. Do NOT plow or shovel snow into the roadway. Not only is it illegal, it can cause a serious hazard for motorists. Be careful shoveling wet and heavy snow to prevent back injuries and possible heart attacks. Draft Minutes of Town Board Special Meeting: Dec. 16,

The Town Board of the Town of Rensselaerville held a Special Meeting on the 16th day of December, 2014 at 7 o'clock in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Valerie Lounsbury and the roll was called with the following results:

PRESENT WERE: Supervisor Valerie Lounsbury. Councilman Robert Bolte, Councilwoman Margaret Sedlmeir, Councilman Gerald Wood, Councilwoman Marion Cooke, Town Clerk Victoria H. Kraker

Also present were Investigator Mance and Sergeant Halloran from the Albany County Sheriff's Department and 52 interested citizens.

The purpose of the Special Meeting was to continue the discussion on the Route 85 parking matter.

Supervisor Lounsbury commenced the discussions by making it clear to all involved that the Town had not taken any action, no resolution was passed, nor were any laws passed regarding the parking along Route 85 in the hamlet of Rensselaerville. She stated that she has made several phone calls and the bottom line is that the Town is very limited in what they can do. She has also spoken to Doug Rose and he stated that the double yellow lines will stay.

Supervisor Lounsbury opened the meeting for public comments. Eighteen concerned citizens signed up to be heard at the meeting and most were relieved to learn that the Town had not taken any action despite the rumors that were being generated. Many citizens that spoke up agree that common sense, consideration, and patience are key and at the very least, vehicles should be kept off the road during snow storms to allow plows to navigate safely and efficiently. It was also mentioned that restricting parking would affect property values.

<u>Jost Nickelsberg</u> suggested looking into extending the parking area behind the Hyuck Preserve office building. Supervisor Lounsbury stated that because of its proximity to the stream and for insurance reasons, it cannot be opened up any more than it already is.

<u>Diana Hinchcliff</u> stated that she felt it was not a parking problem, but rather a speed and traffic -type problem. She suggested forming a committee to gather community input and to make recommendations.

Christopher Schiralli thanked the Huyck Preserve for allowing citizens to park their vehicles in their parking lot during snowstorms. He also stated that limiting parking is an intrusion of daily life, creates a hardship for family and friends and patrons of the business and civic organizations. He stated that he is not aware of any reports from first-responder organizations that the parking on Main Street has caused any diminished response times. Mr. Schiralli directed his final statements to Supervisor Lounsbury as follows: the overwhelming opposition to any action that would prohibit parking or change the current parking pattern, from citizens to civic organizations and local businesses, should be referendum enough not to consider any resolutions that would alter the current parking. He asked that due to the significant hardship that would be incurred, that the Town close these proceedings or at least offer a reasonable solution that would not prohibit on-street parking.

Barry Kuhar suggested back in the mid 1990's that the Town Board look into buying property in Rensselaerville for the purpose of parking for the village. Now, twenty years later, the problem remains. The village is congested because people are using it and alternative parking is needed.

<u>Colin Abele</u> is concerned about the ethics of the chain of events that have occurred regarding the parking issue. He suggests that the Town Board look into what led an action being taken by the police without any prior Town Board action. He recommends that any committee that may be formed, check into Councilman Bolte specifically because he understands that it was Councilman Bolte that

Councilman Bolte answered Mr. Abele by confirming that it was in fact himself that that filed the complaint, however, he did not make the complaint as a Board member. Councilman Bolte stated that when he ran for the office of Town Council he did not give up his private rights. The complaint was neither filed by the Town Board nor was it represented as being filed by the Town. He stated that the fact of the matter is that the Motor Vehicle Law states that if a vehicle is parked on the surface of the pavement, it is illegal; if you cross the double yellow line, it is illegal; and if you get hit while you are over that yellow line, you are the one that is liable, regardless of who is actually at fault.

<u>Emileigh Tanner</u> stated that on behalf of the Huyck Preserve, they have been very lenient in allowing people to park in their lot during a snow storm, but it is not a solution. Alternative parking is needed.

<u>Bob Tanner</u> stated that as chief of the Fire Department, on occasions, parking on the Grist Mill side has caused a problem. Once they have actually had to stop and ask that a vehicle be moved so that the fire department could get through; luckily it was not an emergency call. He also stated that for safety reasons, there must not be parking at the foot of Pond Hill nor at the end of Route 85 where larger emergency vehicles need the room to turn.

<u>Sharon Costello</u> submitted written comments, but will summarize as follows: most recognize there is limited parking, but they are courteous and work it out. The problem is with those that want to drive through the village at unreasonable speeds. Speed and large vehicles on a roadway that is not designed for them is a problem. Speed is also a concern when it comes to pedestrians.

<u>Charles Burgess</u> chairman of the RHDA is in agreement with most of all the above comments and recommends that any action that may be taken in the future take into account the historical essence of the Town of Rensselaerville. He also volunteered to help in any way.

<u>Dawn</u>, Executive Director of the Huyck Preserve, confirmed that there simply is not enough space to extend the parking area behind the Mill House. However, there is an unspoken rule that during storms people are permitted to use their parking lot. She stated that she would like it to remain 'unspoken', because if it becomes 'spoken' it would come down to not allowing anyone to park there. However, this is not a long term solution.

<u>Investigator Mance</u> began by thanking everyone for coming out for the meeting and for all the emails. She confirmed that a complaint was filed and because it was a legitimate concern, the Sheriff's Department was sent to investigate. She agrees that a blind-eye has been turned to the parking situation in her fourteen-year tenure with the Sheriff's Department. And, although, she has never written a ticket she has had to knock on some doors to have people move their vehicles because they were in violation. She stated that she was not present to provide a solution, but rather to explain and clarify the law. Simply because Rensselaerville is unique, it is still part of New York and the laws of the New York State Vehicle and Traffic Law are applicable. She noted that although some laws are black and white, some do fall into a gray area and are open to interpretation. She asked that people keep in mind that if the fire, police, or ambulance were coming to their house, and are unable to get through because cars are parked in the way, and it took even an extra two minutes for them arrive, two minutes is a lifetime.

Investigator Mance explained that Councilman Bolte was correct when he stated that regardless of who is actually at fault, if you are the one on the wrong side of the yellow lines when an accident occurs, you are considered the one at fault.

Supervisor Lounsbury thanked everyone for attending. She stated that there would be no immediate solutions, but asked that everyone to be courteous and use common sense in the meantime.

A motion was made by Councilman Bolte to adjourn the meeting at 8:02 PM; 2nd by Councilwoman Sedlmeir. *Motion carried: Ayes (5) Lounsbury, Bolte, Sedlmeir, Wood, and Cooke; Nays (0)*
