## **OLD BUSINESS**

- 5. Supervisor Lounsbury received a letter of resignation from Edward Pizzigati, Substitute Refuse/Recycling Coordinator.



#### **HIGHWAY DEPARTMENT**

- 1. Highway Superintendent Bates reported that the Highway Department's snow and ice preparation has been completed; salt has been delivered; and the trucks have been serviced. Currently, the Highway Department has been busy cutting and trimming trees.
- 2. The new Western Star truck is due to be delivered any day.
- 3. Superintendent Bates announced that the stop signs have been installed at the intersection of Gerard and Sayre Roads and that seven 'Right to Farm' signs have also been erected.
- 4. Highway Superintendent Bates wished to thank Councilman Bolte on behalf of himself and the Highway Department for all he has done. He noted the vast amounts of money Bob has saved the Town. Bob has maintained the shop; spent time troubleshooting the trucks; done electrical work; done plumbing work; everything that breaks, Bob fixes. Bob has purchased tools with his own money; has donated his personal tools; and has supplied a great amount of scrap steel from Albany Fabrication for repairs. Bob spear-headed the purchase of two Oshkosh trucks from the Town of Catskill, largely through donations. He sold the Town a patch roller at a very fair price when the Town desperately needed one; and the roller has significantly improved the quality of the hand-patching. He has researched websites for used equipment. Superintendent Bates added that personally, Bob always offered support and encouragement when the 'road wasn't always so smooth'.

Bob, again, extended his offer to continue to help in any way possible.

## WATER/SEWER COMMITTEE

- 1. Water/Sewer Treatment Officer Story reported that, for the month of November, 345,500 gallons of water was filtered (an average of 11,517 gal/day); and 189,000 gallons of sewage was pumped (an average of 6,300 gal/day).
- 2. Officer Story noted that the concrete inside the tank is in seriously bad shape. As soon as Officer Story gets his confined-space training, he will be able to handle some of the issues before him.
- 3. Officer Story feels that the District needs to resign itself to the fact that meters should be installed. He feels that unless residents are held responsible for their usage, there are no consequences for misuse. Having proper meters would allow Officer Story the ability to monitor usage and if there were a leak, he could remedy the situation immediately

Councilman Bolte had offered the District meters that could be read remotely, twice in the past. He is willing to extend the offer one more time. Although Officer Story would prefer a more updated version which would allow him to monitor the water usage from a cell phone, he will present Councilman Bolte's offer to the Committee.



## **Internet Safety Recommendations**

With more and more people conducting business over the Internet, the following information from Craigslist might prove beneficial to many.

## **Avoiding Scams**

- **Deal locally, face-to-face** —follow this one rule and avoid 99% of scam attempts.
- Do not extend payment to anyone you have not met in person.
- Beware offers involving shipping deal with locals you can meet in person.
- Never wire funds (e.g. Western Union) anyone who asks you to is a scammer.
- Don't accept cashier/certified checks or money orders banks cash fakes, then hold you responsible.
- Transactions are between users only, no third party provides a "guarantee".
- Never give out financial info (bank account, social security, Paypal account, etc).
- Do not rent or purchase sight-unseen—that amazing "deal" may not exist.
- Refuse background/credit checks until you have met landlord/employer in person.

## Recognizing scams

## Most scams attempts involve one or more of the following:

- Email or text from someone that is not local to your area.
- Vague initial inquiry, e.g. asking about "the item." Poor grammar/spelling.
- Western Union, Money Gram, cashier check, money order, paypal, shipping, escrow service, or a "guarantee."
- Inability or refusal to meet face-to-face to complete the transaction.

#### **Examples of Scams**

- 1. Someone claims your transaction is guaranteed, that a buyer/seller is officially certified, OR that a third party of any kind will handle or provide protection for a payment:
  - These claims are fraudulent, as transactions are between users only.
  - The scammer will often send an official looking (but fake) email that appears to come from craigslist or another third party, offering a guarantee, certifying a seller, or pretending to handle payments.

#### 2. Distant person offers a genuine-looking (but fake) cashier's check:

- You receive an email or text (examples below) offering to buy your item, pay for your services in advance, or rent your apartment, sight unseen and without meeting you in person.
- A cashier's check is offered for your sale item as a deposit for an apartment or for your services.
- Value of cashier's check often far exceeds your item—scammer offers to "trust" you, and asks you to wire the balance via money transfer service.
- Banks will cash fake checks AND THEN HOLD YOU RESPONSIBLE WHEN THE CHECK FAILS TO CLEAR, sometimes including criminal prosecution.
- Scams often pretend to involve a 3rd party (shipping agent, business associate, etc.).

#### 3. Someone requests wire service payment via Western Union or MoneyGram:

- Deal often seems too good to be true, price is too low, or rent is below market, etc.
- Scam "bait" items include apartments, laptops, TVs, cell phones, tickets, other high value items.
- Scammer may (falsely) claim a confirmation code from you is needed before he can withdraw your money.
- Common countries currently include: Nigeria, Romania, UK, Netherlands—but could be any-

where.

- Rental may be local, but owner is "travelling" or "relocating" and needs you to wire money abroad.
- Scammer may pretend to be unable to speak by phone (scammers prefer to operate by text/email).

## 4. Distant person offers to send you a cashier's check or money order and then have you wire money:

- This is ALWAYS a scam in our experience—the cashier's check is FAKE.
- Sometimes accompanies an offer of merchandise, sometimes not.
- Scammer often asks for your name, address, etc. for printing on the fake check.
- Deal often seems too good to be true.

### 5. Distant seller suggests use of an online escrow service:

 Most online escrow sites are FRAUDULENT and operated by scammers. \* For more info, do a Google search on "fake escrow" or "escrow fraud."

## 6. Distant seller asks for a partial payment upfront, after which they will ship goods:

- He says he trusts you with the partial payment.
- He may say he has already shipped the goods.
- Deal often sounds too good to be true.

## 7. Foreign company offers you a job receiving payments from customers, then wiring funds:

- Foreign company may claim it is unable to receive payments from its customers directly.
- You are typically offered a percentage of payments received.
- This kind of "position" may be posted as a job, or offered to you via email.

Remember: It's far better to be safe than sorry.
