Draft Minutes, Town Board Work Meeting, March 6, 2018

The Work Meeting of the Town Board of the Town of Rensselaerville was held on the 6th day of March 2018 at 7:00 in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Steven Pfleging and the roll was called with the following results:

PRESENT WERE: Supervisor Steven Pfleging, Councilwoman Marion Cooke, Councilman John Dolce, Councilman Jason Rauf, Councilwoman Margaret Sedlmeir, Town Clerk Victoria H. Kraker

Also present was one interested citizen.

AUDIENCE COMMENTS

Marie Dermody noted that the December 14, 2017 minutes were not posted on the website. It was explained that these minutes were not posted yet because they are still up for discussion.

Also, she suggested placing a job description along with any advertisements for employment opportunities.

2017 were discussed.

- . Authorization is needed to place another block ad in the *Altamont Enterprise* seeking letters of interest for a Town Justice. Training will take place the week of April 9th through 16th. A Special Meeting for the purpose of appointing a Town Justice will also need to be scheduled.
- 3. Councilwoman Cooke will present her disclosure statement on Thursday.
- 4. Kenyon Road has been closed from County Route 352 (Fox Creek Road) to the intersection of Roney Road, except for local traffic and emergency vehicles. The section of Kenyon Road from the intersection of Roney Road to County Route 358 is closed completely. Superintendent Bates has spoken to the Forest Ranger who has indicated that the state will purchase and grade the shale for the upper section, but the Town has been asked to haul it. Repairs to the lower section will be the responsibility of the Town.
- 5. A decision on how to proceed with reimbursing 'Phase II' Sewer District users will need to be made on Thursday.
- 6. A Public Hearing will be held on Thursday regarding proposed Local Law No. 3 of 2018. Supervisor Pfleging noted that there were many more questions than answers at this point. Councilwoman Cooke inquired about a moratorium.

NEW BUSINESS

- 1. A decision will need to be made regarding the liability insurance as the current policy is due to expire shortly. Trident has reviewed the Town's current policy and offered a renewal premium of \$34,680.43 down \$6,437.33 from last year's. There is, however, an additional \$3,000 for 'downstream exposure' coverage for the dam. NYMIR's quote came in at \$29,583.35 plus an additional \$11,336.00 for the 'downstream exposure' coverage. Also, there are stipulations with joining NYMIR in the event the Town discontinues coverage with them.
- 2. The Highway's on-line bidding authority will need to be renewed on Thursday.
- 3. Authorization will be needed to place an ad for the purpose of soliciting bids for the cutting of the hay fields between Town Hall and the Public Safety Building.

Draft Minutes, Town Board Public Hearing, March 8, 2018

The Town Board of the Town of Rensselaerville held a Public Hearing on the 8th day of March, 2018 at 6:45 in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Pfleging and the roll was called with the following results:

PRESENT WERE: Attorney Thomas Fallati, Supervisor Steven Pfleging, Councilwoman Marion Cooke, Councilman John Dolce, Councilman Jason Rauf, Councilwoman Margaret Sedlmeir, Town Clerk Victoria H. Kraker

Also present were Assessors Donna Kropp and Jeffry Pine and 22 interested citizens.

The purpose of the Public Hearing was to receive public input on proposed Local Law No. 3 of 2018 entitled "Local Law Opting Out of Exemptions for Certain Energy Systems Provided by New York State Real Property Tax Law §487."

A motion was made by Councilman Rauf to open the Public Hearing at 6:46pm; 2nd by Councilman Dolce.

Attorney Fallati presented a brief overview of the proposed Local Law which allows for a 15 year exemption for solar, wind, or farm waste energy systems. The added value of a property is exempted from taxation for a 15-year period. The proposed Local Law would allow a municipality to opt-out of the exemption. Also, under the proposed law, a municipality would be allowed to condition a permit for one of these systems on a PILOT (payment-in-lieu-of-taxes) agreement.

Councilman Dolce wished to make it clear that the reason everyone was in attendance was to *discuss* the proposed law and the future of solar in the Town. The Board has *not* decided to opt-out. There are many, many more questions than there are answers at this point.

<u>Marie Dermody</u> stated that she wished it to be known that she didn't think there was any dark intent on the part of the Town Board regarding this matter. She sensed that the Board will do the right thing. However, she was concerned that the Town has an attorney that drafted and presented a local law without any authorization from the Town Board. Also, only three members were present at the time the Resolution was presented and all three moved forward to schedule the Public Hearing on something they knew nothing about. She feels that opting-out of the tax exemption needs much more research; all consequences, those intended and those not intended must be addressed. [*Editor's Note: My entire written statement can be found on page 47.*]

<u>Jeannette Rice</u> felt that opting out of the tax exemption would put solar development at a standstill – getting rid of the tax break is not a good idea. She recommends scrapping the local law and putting a moratorium on all new commercial and residential permits for solar and then proceeding to develop the Town's zoning law.

<u>April Caprio</u> was against opting out of the exemption and felt the Town should move forward with sustainability projects.

<u>Richard</u> Tollner is the co-author of a solar farm policy in one town and an Assessor in another Town that opted-out. Mr. Tollner stated that solar farms don't use your roads and they don't attend your schools, but they do help pay your taxes. If there is someone or something out there that adds to the tax income, but not to the expense of the town, it's a reason to look at it. However, one also needs to look at what good and what harm a solar farm can do. Mr. Tollner has worked with NYSERDA, has attended seminars, has worked with investors and the State of New York. He recommended doing research, looking into solar farm policies, and contacting other towns to try to make the best decision. In his experience people's main concerns are cosmetics, set-backs, and reliability. Solar farm companies are

bonded; they have to pay for the removal of their solar farm in 15 years and the money has to be in process from day-one before they start building. He felt there is a way to have solar farms come in - to gently grow the town - without messing up the vistas, without messing up the traffic, without harming the neighbors or the beauty of Rensselaerville and yet increasing the tax income without burdening the expenses.

The solar farm industry in the past seven years across New York State has formulas is place so there should be no over-taxing or under-taxing. The solar farm companies and the engineers know exactly what they cost to build. Solar farm companies want to come to towns with solar farm policies. The terrain of the land is also an issue – the hillier the land – the more expensive the project is. One will not see anything on the side of the Catskills because of the labor of the installation.

Mr. Tollner feels it is a math and environmental issue, both of which can be addressed just by doing a little homework and by looking at what neighboring towns did and what others did not.

<u>Rebecca Platel</u> stated that most of what she wished to address was already covered. She is in favor of solar development especially if it is done in a way that benefits the community. She felt that passing the proposed Local Law would deter solar development of all kinds and suggested separating the decision of opting-out from the bigger discussion of solar development.

Robin Reynolds was in attendance on behalf of the Capital District Regional Planning Commission (CDRPC). She noted that many municipalities are struggling to figure what the best thing is to do. There is a lot of information out there and sometimes it is difficult to know where to start. CDRPC has a grant through NYSERDA called the Clean Energy Communities Program where they provide technical assistance and access to funding for issues such as these. She felt that opting-out may inhibit solar development; staying in would allow the ability to negotiate with solar developers to come up with a PILOT (payment in lieu of taxes) program. CDRPC is also working on a project in which they have analyzed some of the land in Rensselaerville for solar development and where zoning may line up with where the solar resources are.

<u>Jeff Pine</u>, an Assessor for the Town of Rensselaerville, stated that he is all for alternative energy. He does not understand how a company, when given 15-years tax-free, can agree to a PILOT program. He feels that solar companies are drawn to areas where there are no regulations. They are not interested in the environment, only a steady return on their money. There is money to be made for the Town. The Town is losing taxable revenue. He feels if solar farms are going to come in to the Town, they should pay a little bit in taxes.

Residential solar is not taxable. The \$40,000 system put in ten years ago is now \$5,000 to install and that 10-year-old system is now obsolete. Mr. Pine does not believe that opting-out will stop solar farms from coming and may give them an incentive to do a PILOT program.

Supervisor Pfleging read two written submissions as follows:

To the Town Board:

Your proposal to opt out of tax exemptions that would encourage renewable energy systems to fairly compete with those already existing that have deleterious impact globally has just come to my attention.

While the political climate in the world – ranging from village to town to city to state to country to global powers – appears to be in a state that discourages the ordinary citizen from even attempting to influence the course of things, I am impelled to write, if briefly and with sincere conviction.

It's a pity that our town board will make it harder with this law for energy sources much needed now and so promising for the future, to develop in our community. My hope is that the political agenda of those

involved in this action will take a back seat to the need of citizens in the Town of Rensselaerville to access various new energies. These developing resources are already necessarily more costly for the moment than the standard ones impaction the planet adversely. Under this proposed law, the citizens you represent will be paying even more for utilities with your proposal to withdraw tax exemptions for these new energy sources that are so clearly needed and whose time has finally come.

To the Town Board:

I am unable to attend the meeting this evening. I ask that my comments be read into the public record.

I want to thank the board for being forward-thinking in balancing the need for equitable property taxation with preserving the historic character of our town. Having carefully reviewed New York State Real Property Tax Law §487 and its specific provisions, I want to state that I am against proposed Local Law 3. The 15-year exemption from increased property taxation has already been if effect for many years and was thoughtfully designed with the needs of all citizens in mind while allowing municipal governing bodies discretion in addressing such matters as commercial solar applications. To opt out, as has been proposed, removes important mechanisms the law provides and I do not believe it is an appropriate solution to any current or future matter facing the town.

AUDIENCE COMMENTS

Richard Amedure expressed his concerns regarding the damage that is being done by the logging operation on State Lands bordering Kenyon Road and CCC Road.

CCC Road is a disaster and now Kenyon Road is a disaster. The land is no longer able to be used for recreation. The land is being clear-cut. The Town will be left holding the bill. The logging trucks cannot make it out of the road any longer so a dozer is sent in to pull the trucks out. Each time a dozer is sent, another several inches of road surface is taken away.

Another concern is everything that is left behind is dead and dry and is a potential fire hazard.

Councilwoman Cooke questioned whether the lands would be re-planted. Mr. Amedure indicated that according to the Forester, who used to have 47 people working the State Lands, is now down to eight. 70-80 years ago the area was all open fields; there was no litter; natural succession only allows scrub brush to take over, not timberland.

CORRESPONDENCE

- 1. Supervisor Pfleging read a letter from the Westerlo Volunteer Fire Company expressing their sincere appreciation for the use of the Senior/Youth bus. A \$50.00 donation from the Firefighters Fund of the Westerlo Volunteer Fire Company was made on behalf of the members to support the Senior Bus program.
- 2. A donation of \$25.00 was made by Beatrice Smith of Westerlo to be put towards the Senior Bus/Car fund.

REPORTS

HIGHWAY DEPARTMENT

1. Superintendent Bates expressed his concerns, as well, for the events on the State Lands and his distaste for the fact that the DEC is allowing it to happen. He called it an 'ecological disaster'; the trails are gone; it's a mud fest; the roads, the streams, the trees and the forest are being destroyed.

Superintendent Bates has been in touch with the DEC, the Forest Rangers and the State Forester who essentially told him there was nothing he could do; the Town roads were going to be used and there was nothing that could be done to stop them.

- 2. Superintendent Bates reported no problems with all the snow that has fallen recently an estimated 40-50" within a six-day period. Although the crew is weary, there have been no incidents, no road closures, and all the equipment is in good condition.
- 3. Many of the dirt roads are not in good shape. The fluctuations in temperatures and the continuous freeze-thaw cycle have been detrimental to the dirt roads especially. The Highway has been trying to use smaller trucks to plow where possible and have loaded the trucks lightly in an effort to preserve the roads and not contribute to further damage.
- 4. The bid packages have been sent out.
- 5. Superintendent Bates has attempted to close Kenyon Road; signs are up, but the logging trucks are still running on it. He has the legal authority to close the road based on the damage being done. He feels it is a law enforcement issue at this point. Superintendent Bates met with the State Forester and the logger and an agreement was made that they would not use the portion of Kenyon Road between the intersection of Roney Road and County Route 352, but that they would continue to use the seasonal/upper part of the road. That has not been the case. The State Forester did say, however, that there were monies available and that he would purchase the materials to repair the road when the logging operation is finished sometime in August.
- 6. Attorney Fallati addressed the weight limit ordinance which would impose weight limit restrictions on town roads. The Town would be authorized to bar vehicles with a gross weight of 6 tons or more on a temporary basis from the date of the ordinance through May 1st unless otherwise determined.

There is a provision for a fine for violations, but Attorney Fallati will look into whether the driver can be held liable for any damages. Attorney Fallati will also check into the wording of the ordinance so it is *not road specific*, but rather to have it cover all Town roads, at the discretion of the Highway Superintendent.

Superintendent Bates wishes for the Town to have a tool to use when the situation calls for. Temporary weight limit restrictions would be dependent on weather conditions, road conditions and the use of the road – who is using it and for what purpose.

SUPERVISOR

- 1. The Town declared a State of Emergency during the most recent snow storm. Supervisor Pfleging wished to thank Highway Superintendent Bates and his Department for a phenomenal job given the circumstances. Superintendent Bates noted that it was one of the worst storms to keep up with.
- 2. Supervisor Pfleging wished to remind everyone about the opioid awareness program on March 21st from 6-8pm at Town Hall.
- 3. Supervisor Pfleging and Deputy Supervisor Dolce visited the Lake Myosotis dam. The monthly report on the status of the dam noted a settling of the rock behind the valve house and there is a concern that there may be some leakage. Supervisor Pfleging has been in touch with the engineers who will be sending a report. A diver may be coming in to take pictures so as to get a better grip on what may be happening.

ATTORNEY

1. Attorney Fallati read the Resolution to renew the Highway Superintendent's authority to participate in on-line bidding as follows:

RESOLUTION OF THE TOWN OF RENSSELAERVILLE TOWN BOARD

WHEREAS, from time-to-time, the Highway Superintendent has requested from the Town Board approval to bid on equipment available in an on-line auction; and

WHEREAS, the Town Board has found the auction process to be financially beneficial, allowing the Highway Superintendent to acquire useful equipment at a fraction of the cost of the acquisition of comparable new equipment; and

WHEREAS, Section 142(1) of the Highway Law permits the Town Board to authorize the Highway Superintendent to purchase equipment, tools and other implements to be used for highway maintenance, construction or reconstruction, snow plows or other devices for the removal of snow from the highways from monies appropriated for that purpose without prior approval of the Town Board, and in an amount or amounts to be fixed, from time to time, by the Town Board; and

WHEREAS, the Town board has determined that it is in the public interest to grant the Highway Superintendent such authority;

NOW THEREFORE, BE IT RESOLVED by the duly convened Town Board of the Town of Rensselaerville, Albany County, New York, that (1) the Highway Superintendent is authorized to bid on, and to purchase, equipment, tools and other implements to be used for highway maintenance, construction or reconstruction, snow plows or other devices for the removal of snow from the highways from monies

appropriated for that purpose without prior approval of the Town Board, through June 30, 2018, up to an amount of \$10,000; (2) this resolution may be reviewed and re-approved quarterly; (3) the Highway Superintendent shall provide the Town Supervisor prompt notice of any bids and purchases made pursuant to this resolution; and (4) nothing in this resolution is intended to limit the Town Board's authority, by subsequent resolution, to modify or rescind this authority generally or with respect to a particular prospective purchase.

WHEREAS, the Town Board finds that there is a cost to the Town associated with providing copies of Justice Court civil and criminal dispositions and that the Town is not reimbursed for such costs; and

WHEREAS, the Town Board, in accordance with Municipal Home Rule Law §10(1)(ii)(a)(9-a), which authorizes the Town to adopt and amend local laws relating to the fixing, levy, collection and administration of charges, rates, and fees, the Town Board has prepared a proposed amendment to Chapter 114 of the Town Code of Rensselaerville to add a Justice Court a fee of five (\$5) dollars for copies of Justice Court dispositions;

AUDIENCE COMMENTS

Marie Dermody read a letter she requested become part of the minutes:

There are several comments that need to be made prior to you entering into Executive Session to discuss "employee history." And I will preface these comments with the statement that I did not ask for nor do I have permission from the Town employee to address the Town Board regarding this matter. This is strictly on me.

1. Last month, when you called the employee to join you in Executive Session and he announced he was bringing in a witness to the proceedings, you cancelled his "invitation." Instead, you had Supervisor Pfleging call him into his office to discuss the executive session matter. Section 105(2) of the Open Meetings Law states that "Attendance at an executive session shall be permitted to any member of the

public body and any other persons authorized by the public body." That being said, you could permit the presence of the witness, but are not required to do so. If you have nothing to hide, you have no reason to resist this action. Why would 5 Town Board members and an attorney be intimidated by the presence of a witness? I would suggest that you make this a Town Board policy, one that allows the presence of a witness during Executive Session proceedings when dealing with employee work history or discipline.

And, yes, Executive Session proceedings are confidential. But a meeting in the Supervisor's office is not. I can no longer abide by my initial agreement to keep that conversation private. What I perceive as abuse of power and discriminatory practices must be exposed.

2. It has come to my attention that the Town Board has created a job description for this employee. According to Supervisor Pfleging, he created the job description and the Town Board "refined" it in Executive Session. Having seen a copy of this job description, it is safe to say it is generic and can be applied to any and all who hold the position of code enforcement officer/building inspector. It is not specific to the "work history" of this particular employee. The creation and refinement of a job description is NOT a matter that should be conducted in Executive Session. You have again violated the Open Meetings Law.

In addition, you are requiring this employee to sign this job description as if it were a legal and binding contract. Unless you can prove unequivocally that this practice is being applied to all appointees as a condition of retaining their position in Town government, we clearly have a case of harassment and discrimination.

3. We have Town Board members scouring the countryside looking for projects lacking the proper paperwork with the office of the building inspector/code enforcement officer. And I believe you have come up empty-handed. You seem to be conducting a vengeful "witch hunt" looking for any excuse to terminate this person's appointment with the Town. Again, unless you can prove that you are exercising this same scrutiny with all other appointees, we clearly have a case of harassment and discrimination.

I respectfully request that this statement be entered into the minutes in its entirety so that the rest of the community is informed of this matter.

Town of Rensselaerville (PROPOSED) LOCAL LAW NO. 3 OF 2018

A local law to Opt-Out of the exemptions provided by New York State Real Property Tx Law §487.

Section 1. Title:

This law shall be known as the "Local Law Opting out of Exemptions for Certain Energy Systems Provided by New York State Real Property Tax Law §487.

Section 2. Purpose and Intent:

The Town Board has determined that this Local Law is to provide no exemption from taxation as authorized in Real Property Tax Law Section 487. Real Property Tax Law Section 487 (8) allows a municipality to opt-out of the exemption from taxation with respect to any solar, wind energy system or farm wast energy system.

Section 3. Authority:

This local law is enacted by the Town Board of the Town of Rensselaerville pursuant to its authority to adopt local laws under the New York State Property Tax Law Section 487 (8) and the Municipal Home Rule Law Section 10.

Section 4. Opt-Out of Exemption:

Chapter 194 of the Town Code is hereby amended to provide as follows: Pursuant to Real Property Tax Law Section 487 (8), no exemption from taxation shall be applicable with respect to any solar or wind energy system or farm waste energy system, as provided for in Section 487.

Section 5. Severability of Provisions:

Should any section or provision of this local law be declared null, void, voidable, or invalid, such finding shall not affect the validity of the remaining portions of this local law.

Section 6: Effective Date:

This local law shall take effect pursuant to the provisions of Municipal Home Rule Section 27.

End of Law

Commentary #1

The issue regarding the Code Enforcement Officer/Building Inspector has been going on for several months now. I stand by my Audience Comments delivered at the March 8, 2018, regular Town Board meeting. The individual currently holding this appointed position is up-to-date on all his NYS training and has held the position for 20 years. It is a part-time position paying \$14,930 per year. It is safe to say he knows more about the responsibilities of the job than the expertise of all Town Board members combined.

What follows is a snapshot of the job description the Town Board created in executive session.

<u>General Purpose of Position</u>—Perform inspections of residential and commercial construction, both new and existing, for adherence to applicable codes and ordinances.

<u>Major Duties and Responsibilities</u>—Perform on-site inspections of new and existing structures for compliance with adopted codes and ordinances, structural quality and safety.

- -Verify that structures are constructed in accordance with the approved submitted plans and specifications.
- -Respond to complaints, that are in writing, of dangerous buildings by inspecting and reporting dangerous conditions, evaluating the complaint and taking appropriate actions based upon adopted codes, town and state laws.
- -Follow up with stop work correspondence; ensuring appropriate action has been taken to correct the situation.
- -Perform on-site inspections of the new and existing structures, enforcing all applicable
- -Verify plumbing and mechanical system installations are in accordance with approved drawings.
- -Meet with architects, engineers, design professionals and contractors regarding proposed construction projects.
- -Issue permits based upon approved construction plans and specifications.
- -Provide contractors, builders and any other individuals with assistance and answers to code compliance questions.
- -Represent the Building Dept. as a professional witness in court and special hearings as required.
- -Continue professional development through conferences, seminars, workshops and other training in order to keep up to date on all code and certification requirements.
- -Use various computer programs and data bases for issuing permits, writing correspondence and tracking correction notices.
- -Work efficiently with Clerk as provided.
- -The person in this position (code enforcement/building inspector) will spend some time in office, reviewing plans, answering letters, emails or phone calls. Writing reports and scheduling inspections.
- -Considerable time is spent in the field inspecting construction sites with an exposure to a variety of, sometimes, extreme weather conditions.

- -The person in this position is exposed to extreme noise, cramped spaces, poor lighting and ventilation during inspections.
- -Physical work for this position incudes and is not limited to, climbing ladders, crawling in confined spaces, walking and standing while conducting inspections, bending, carrying, climbing, holding and gripping objects. Safety equipment, such as, safety vest, hard hat, ear protection and eye protection will be provided.
- -Work effectively and courteously with associates, development community and the general public.
- -Work as a team member with other employees.
- -Handle multiple tasks simultaneously with frequent interruptions.
- -Maintain professional composure in heated situations.
- -Your set office hours are weekly, Thursday 8-10 am and 7-9 pm. Please punch in as to better keep track.
- -Be pro-active and follow up on all open permits and violations.
- -Make a spread sheet, to go with each permit, that itemizes your inspections, ie: footings, foundation, framing, insulations, etc. Please include name of permit holder, address, permit description, dates of inspections, time and initials of the contractor and yourself. Please supply to the town board on a monthly basis.
- -Turn in mileage on a monthly basis.
- -Any classes or training, please supply documentation.
- -Must respond to all fire calls, in accordance with to Local Law #4 of 2007, as well as NYS Uniform Fire Prevention and Building Code

It is my strongly held opinion that the creation and refinement of a job description that is generic (applicable to anyone holding the position of Code Enforcement Officer/Building Inspector) is <u>not</u> a legal reason for entering into executive session. I presented this issue to Robert Freeman, Executive Director for the Committee on Open Government. His response: <u>When the issue involves the creation or elimination of a position (irrespective of who might hold that position), there would be no basis for conducting an executive session.</u>

In a moment of frustration and anger, the supervisor announced in a public forum that the Town Board felt compelled to do this because the employee wasn't doing everything expected of him. (And yes, I have the audio recording of this outburst.) So, another way to look at this situation...if there was no job description to begin with, in what universe would or could a Town Board hold an employee/appointee accountable for adhering to the terms of a non-existent job description?

Although I would love to claim that I'm always right, I know that is certainly not true. However, I will go to bat for anyone I feel is being treated unfairly or in a discriminatory way. I feel that there are personal or hidden agendas at play on the part of certain Town Board members which is something none of us should tolerate from our government officials.

Commentary: Special Town Board Meeting, March 29, 2018

The three items on the agenda for this special Town Board meeting were the appointment of a Town Justice, the appointment of the Code Enforcement Officer/Building Inspector, and to rescind the public hearing regarding Local Law #4 of 2018.

Once the meeting was convened by Supervisor Steve Pfleging, he immediately entertained a motion to enter into Executive Session to discuss the justice position. Having anticipated such a move, I had contacted Bob Freeman, Executive Director of the Committee on Open Government, and explained what I suspected would happen. His response to my query regarding conducting such discussion behind closed doors was "Although the law states that a board may hold an executive session to discuss 'matters leading to the appointment...of a particular person,' in the only decision dealing with a situation in which a board was discussing filling a vacancy in an elective office, the court held that the discussion must occur in public." (my underlining) I contend that anything discussed in an interview would be open for discussion in a campaign for elective office. The Town Board chose to ignore the expertise of the Executive Director for the Committee on Open Government and instead follow the advice of the attorney, whose counsel has misinformed the Town Board on a number of occasions. I was told that the Town Board would conduct the interviews in executive session and discussion would take place in the open meeting afterwards.

True to form, this did not happen. As soon as the Town Board returned from executive session, the supervisor made the motion to appoint Muriel Fraser as town justice, seconded by Marion Cooke, and passed unanimously. There was absolutely no public discussion! When questioned at the end of the meeting why there was no public discussion, the supervisor said there was no need for one. I happen to beg to differ. Any one of the three candidates for the position would be an acceptable choice, but we as residents and taxpayers have a right to know why one was chosen over the others for an elective office.

The second matter concerned the appointment of the Code Enforcement Officer/Building Inspector. He had been appointed for a "probationary" 3-month term with the expectation that this new appointment would take him to the end of the calendar year. He had already agreed to a job description (see pages 16-17) and informed the Town Board that just one document in that job description took him 8 hours to create. Considerable discussion took place regarding whether or not the appointment should be for 3 months or 9 months. In the end, the Code Enforcement Officer/Building Inspector prevailed and a motion was made to make this appointment end on December 31, 2018. Jason Rauf, Marion Cooke, and Steve Pfleging voted in favor of this motion, Margaret Sedlmeir voted nay, and John Dolce did not cast a vote at all. I say again that it is time to stop this harassment of a town employee.

The last item on the agenda was to rescind the motion to hold a public hearing on proposed Local Law #4 of 2018 regarding an amendment to the newly passed fee schedule. It seems that creating a fee for copies of court dispositions is not a function of the Town Board, but instead of the justice department. So this again begs the question, why didn't the attorney research this matter and counsel accordingly rather than draft a local law and do so without Town Board authorization only to have to rescind it later? This legal firm has been a contractor for this town for over 6 years and will have received well over \$200,000 of taxpayer money by the end of this year. I would hope by now that they would have a better handle on municipal law and provide proper counsel to the Town Board.

Local Law No. 4 of 2018

LOCAL LAW NO. 4 OF 2018

TOWN OF RENSSELAERVILLE, NEW YORK

A local law relating to the imposing of fees for Justice Court dispositions.

Section 1: The Town Board finds that there is a cost to the Town associated with providing copies of Justice Court civil and criminal dispositions and that the Town is not reimbursed for such costs. Therefore, the Town Board finds that it would be in the best interest of the Town to authorize the imposition of a fee to be charged for providing a copy of a Town Justice Court disposition.

Section 2: The Town Board, as authorized by Municipal Home Rule § 10 (1)(ii)(a)(9-a) to adopt and amend local laws relating to the fixing, levy, collection and administration of charges, rates, and fees, hereby authorizes the amendment of Chapter 114 of the Town Code of Rensselaerville Town Code to add the following fee:

Justice Court, copy of any disposition - five dollars (\$5).

Section 3: This local law shall take effect pursuant to the provisions of Municipal Home Rule Section 27.

Commentary #2

I have the distinct advantage of having been at Tuesday's work meeting at which this local law was discussed. Having listened to this discussion, I can assure you that the following comments are far less bombastic than they would have otherwise been. Let it be known that I do not think for a minute that there was dark intent on the part of the Town Board with regard to this matter. And I sense that the Town Board will do the right thing.

However, what transpired regarding this matter concerns me on two fronts:

- 1. We have an attorney to the Town that drafted and presented a local law without any authorization from the Town Board. And then wrote the law to state in Section 2 that "The Town Board has determined..." Really? It matters not to whom he spoke to and in what depth. Without Town Board authorization to proceed, he absolutely overstepped his responsibility as legal counsel. This cannot be allowed to happen again...ever!
- 2. I acknowledge that both Supervisor Pfleging and Councilman Rauf are new to the Town Board and not necessarily privy to all the decisions and actions that took place before their arrival on the Town Board. And I acknowledge that only 3 Town Board members were present at the February 8, 2018 Town Board meeting at which this resolution was presented to the Town Board by Attorney Bill Ryan. However, all three moved forward to approve the resolution and schedule this Public Hearing, without having a clue as to what this local law entailed. Think about it ... you approved a resolution the subject of which you knew nothing about. This too, cannot happen again ... ever! Hindsight being 20-20, you could have easily tabled this matter until the full board was present and a meaningful discussion could take place.

At this point, I think we can all agree that this matter of opting-out of tax exemptions for solar needs far more research and investigation on the part of the Town Board. You need to examine all the consequences of enacting such a law, the intended as well as unintended consequences. And, moving forward, I expect that this will happen.



Did You Know?

It seems that our Town Board has taken on a new process in this new administration, one that I feel is detrimental to good governance. For both Local Law #3 of 2018 and Local Law #4 of 2018, neither concept appeared before the Town Board for healthy, open and public discussion about the inherent issues (opting out of tax exemption for solar, amending newly passed fee schedule to include cost for copies of court dispositions.) In both cases, the majority of the Town Board was blind-sided by drafts of local laws they knew nothing about.

No one Town Board member should have the singular authority to direct the attorney to the town to draft a local law! And the attorney should know not to proceed with such a directive without the legal authorization of a majority of the Town Board. Short-cutting this process does a great disservice to the people these elected officials are supposed to represent. As a matter of fact, it is a great disservice to the Town Board members who weren't even given the courtesy of a heads-up!

I suggest that this new procedure be abolished and we return to the right way of doing things: matters of interest or concern are brought before the Town Board for meaningful discussion & allowing public input, then decide whether or not to authorize the attorney to draft a new local law.
