#### Minutes, Town Board Budget Meeting, September 26, 2018

The Town Board of the Town of Rensselaerville held a Budget Workshop on the 26th day of September 2018 at 7:00 in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Pfleging and the roll was called with the following results:

PRESENT WERE: Supervisor Steven Pfleging, Councilwoman Marion Cooke, Councilman John Dolce, Councilman Jason Rauf, Councilwoman Margaret Sedlmeir, Town Clerk Victoria H. Kraker

Also present were two interested citizens.

The purpose of the meeting was to begin the review of the 2019 Tentative Budget.

Supervisor Pfleging began the review with the General Fund Appropriations. Highlights are as follows:

- $\sqrt{\phantom{0}}$  The Town Board members will be raised from \$3,000 each to \$3,500 each
- √ The Justice Court Clerks will be raised from \$2,400 each to \$2,550 each
- √ The Court's Computer Supply line item will be decreased from \$1,750 to \$500 as their SEI Court Program will now be covered by the State
- √ The line item termed 'Constable' will be changed to read 'Court Officer'. The salary will be increased from \$1,400 to \$1,456 and there will be a one-time Uniform & Clothing increase of \$300
- √ The Town Supervisor will be raised from \$12,500 to \$14,500 and the Equipment line item will be decreased from \$3,000 to \$500. Audit Fees will be increased from \$15,000 to \$19,000 to cover the Accountant's fees
- $\sqrt{\phantom{0}}$  The Assessor's Chairperson will be increased from \$6,535 to \$6,735
- √ Certified Assessors will be raised from \$6,035 each to \$6,235 each
- √ The Assessor's Travel Mileage will be raised from \$200 to \$250 and the Taxes & Assessment and Misc. Contractual line items will each see a \$300 decrease
- √ The Town Clerk's salary will be raised from \$32,780 to \$34,000.
- √ The Deputy Town Clerk, along with all other clerical positions currently at \$12/hour, will be increased to \$13/hour.
- √ The Town Clerk's Travel Mileage will be raised from \$200 to \$300; Fees for Services will be raised from \$730 to \$790; Taxes & Assessment will be increased from \$2,205 to \$2,285; Printing & Advertising will increase from \$300 to \$400; Misc. Contractual will see a \$100 decrease; and Specialty Office Supplies will see a \$50 decrease
- √ Under Buildings, Insurance will decrease by \$2,000; Computer Fees will increase from \$10,000 to \$12,750; Electric will see a \$1,000 decrease and Food & Concessions will see a \$200 decrease □ Under Central Printing & Mailing, the Postage line item will see a \$375 decrease
- √ Under Safety Inspection, the line item for Travel Mileage will see a \$450 decrease; Conferences will be raised from \$150 to \$500
- √ The Annual Budget for the Paramedics will be raised from \$57,000 to \$60,032
- √ The Recycling Coordinator's salary will be raised from \$38,186 to \$38,950; Refuse Charges will increase from \$43,675 to \$48,675; and Misc. Contractual will increase from \$4,000 to \$6,000

#### **Draft Minutes, Town Board Budget Meeting, October 1, 2018**

The Town Board of the Town of Rensselaerville held a Budget Workshop on the 1<sup>st</sup> day of October 2018 at 7:00 in the evening at the Rensselaerville Town Hall, 87 Barger Road, Medusa, NY. The meeting was convened by Supervisor Pfleging and the roll was called with the following results:

PRESENT WERE: Supervisor Steven Pfleging, Councilwoman Marion Cooke, Councilman John Dolce, Councilman Jason Rauf, Councilwoman Margaret Sedlmeir, Town Clerk Victoria H. Kraker

Also present were two interested citizens.

The purpose of the meeting was to continue the review of the 2019 Tentative Budget.

- Nobert Tanner attended the meeting to discuss the budget for the Rensselaerville Volunteer Fire Company. A lengthy discussion ensued over the budget of all three fire companies. It was ultimately the consensus to give each of the fire companies as follows: the Medusa Volunteer Fire Company will receive \$52,500 − no increase from 2018; the Rensselaerville Volunteer Fire Company will receive \$51,000 − a \$2,000 increase over 2018; and the Tri-Village Volunteer Fire Company will be getting \$50,500 − a \$1,500 increase over 2018.
  - The unfunded mandate to provide qualified internal firefighters insurance was discussed and each fire company has been tentatively allotted an additional \$2,500 under Worker's Comp
- √ The Rensselaerville Lighting District's Electric line item will be increased from \$4,550 to \$4,75
- √ The Sewer District's Office Supplies line item will be decreased from \$100 to \$50; Electric will be increased from \$1,200 to \$1,500; the Sewer Charges line item will be eliminated saving \$1,200; the telephone line has been eliminated as well saving \$360; and the Specialty Equipment line will be increased from \$500 to \$1,500
- √ The Water District's Printing & Advertising line item will be reduced from \$100 to \$50; Laboratory will be increased from \$1,300 to \$2,100; and Property Repair will be reduced from \$2,262 to \$2,000

The purpose of the meeting was to continue the review of the 2019 Tentative Budget.

- √ The Highway Superintendent's salary will be raised from \$45,407.50 to \$46,316
- √ The Highway Clerk's line will be capped at \$4,000; down \$600 from \$4,600
- √ According to the Union Contract, the Operator under Maintenance/Roads will be raised from 160,849 to \$165,651.40; and the Operator under Snow Removal will be raised from \$174,458 to \$181,207.30. Also, under the Contract, the Clothing Allowance will be increased by \$175
- √ Under Maintenance/Roads, the Road Material line will be increased by \$10,000 to \$190,000
- √ Under Road Machinery, the Truck line item will be increased by \$3,000 and the Equipment Repairs & Maintenance line will be increased by \$2,5000 to \$61,500
- $\sqrt{\phantom{0}}$  Under Snow Removal, the Sand & Salt line (formerly termed Road Material) will be increased by \$2,000 to \$77,000
- √ Town Justice Bates and Town Justice Frasher attended the meeting in an attempt to preserve their request to have their Clerk's salary raised by \$500 each instead of the \$250 each the Board had granted at a prior budget workshop. Upon further discussion, it was agreed upon that the clerks would, in fact, get the \$500 originally requested by the Justices

The larger idea is to address the rural quality of life and economic opportunity in Rensselaerville by strengthening the Town's connections to urban resources. The Carey Institute for Global Good will incur all expenses and would then request payment from the Town, who would in turn submit paperwork to Hudson Valley Greenway for reimbursement.

- 3. Two new applicants have submitted their letter of interest for the Code Enforcement Officer/Building Inspector/Zoning Officer position since the meeting in September.

#### **NEW BUSINESS**

- 1. The Town will have to pass proposed Local Law No. 5 of 2018 Tax Cap Override, in the event that the budget exceeds the tax cap.
- 2. Dates will need to be set for the Public Hearing on the Preliminary Budget and for the Adoption of the Final Budget.
- 3. The Board will have to appoint a Winter Seasonal Highway Employee from Nov 1<sup>st</sup> April 15<sup>th</sup>.
- 4. Town Clerk Kraker presented the Board with the idea of establishing a credit card account with the Bank of Greene County for miscellaneous purchases. Having a credit card would allow the Town to purchase items through business that do not participate in the voucher system as well as eliminate the burden on any employee who makes a purchase with their own funds and then must wait until the next Town Board meeting to be reimbursed.

Superintendent Bates supported the idea by stating that there are vendors that the Town has not been able to do business with because they do not participate in the voucher system and in many of those instances, the Town *could* have purchased items or materials at a lower cost.

Further discussion on the matter will be had at the Regular meeting.

5. The Board will need to appoint a Safety Officer for the upcoming year.

The document wasn't even read aloud so that the Town Board knew what they were adopting. This is **not** the way a Town Board should be conducting business! - 2. Attorney Fallati will read through the proposed Firefighter's Enhanced Cancer Disability Benefits Program. This benefit would increase the Workers' Compensation by a total of \$7,500 and the Board would need to be absolutely certain if it is applicable for budgeting purposes.
- 3. An email has been sent to the Attorney General's office regarding the dissolution of the Rensselaer-ville Volunteer Ambulance requesting the matter to be expedited.

Proposed Local Law No. 5 of 2018 Of the Town of Rensselaerville

A Local Law Overriding the Real Property Tax Levy Limit for Fiscal Year 2019

BE IT ENACTED by the Town Board of the Town of Rensselaerville as follows:

Section 1. Legislative Authority

Chapter 97 of the Laws of 2011 of New York State, incorporated in § 3-c of the General Municipal Law, established a 'tax cap' that generally limits the amount of a municipality's real property tax levy for the upcoming fiscal year according to a formula set out in the statute, but the statute also authorizes local governments, pursuant to General Municipal Law §3-c(5), to override the tax levy limit for the upcoming fiscal year.

Section 2. Override of Tax Levy Limit for Fiscal Year 2019

The real property tax levy limit set out in § 3-c of the General Municipal Law is overridden, pursuant to New York General Municipal Law §3-c(5), for Fiscal Year 2019 and the Town may adopt a budget for Fiscal Year 2019 that incorporates a real property tax increase in excess of the otherwise applicable tax levy limit.

Section 3. This Local Law shall take effect immediately upon filing with the Secretary of State.

In all four instances, the Supervisor's name is listed first, followed by either the Town Clerk or the Bookkeeper. One of our neighboring Towns uses the credit card for purchases through Amazon, for example, where items can be purchased at discounted prices. The average cap is \$3,000.

The Board is leaning towards moving forward, but wishes to establish a written policy for its use, for example, where the physical card would be kept, who would be authorized to use it, as well as any other stipulations they feel should be considered.

- -Provide contractors, builders, and any other individuals with assistance and answers to code compliance questions.
- -Represent the Building Dept. as a professional witness in court and special hearings as required.
- -Continue professional development through conferences, seminars, workshops and other training in order to keep up-to-date on all code and certification requirements.
- -Use various computer programs and databases for issuing permits, writing correspondence and tracking correction notices.
- -Work efficiently with Clerk as provided.
- -The person in this position (code enforcement/building inspector) will spend some time in office, reviewing plans, answering letters, email or phone calls, writing reports and scheduling inspections.
- The person in this position is exposed to extreme noise, cramped spaces, poor lighting and ventilation during inspections.
- Physical work for this position includes, and is not limited to, climbing ladders, crawling in confined spaces, walking and standing while conducting inspections, bending, carrying, climbing, holding and gripping objects. Safety equipment, such as safety vest, hard hat, ear protection and eye protection will be provided.

- Any classes or training, please supply documentation.
- Must respond to all fire calls in accordance with Local Law #4 of 2007, as well as NYS Uniform Fire Prevention and Building Code.

#### **MUSEUM PASSES**

Check the following passes out with your Library Card.

Don't forget to show your card at the Via Aquarium for a \$2.00 Discount.

<u>The Albany Institute of History and Art</u> located on Washington Ave in Albany. The Library offers two museum passes for free admission for a family and a 10% discount at the museum shop. The museum has a number of exhibitions and programs.

<u>The Clark Art Institute</u> in Williamstown, MA. The Library offers a free museum pass for two adult admissions July through December. Opened to the public in 1955, the Clark has become one of the most beloved and respected art museums in the world, known for its intimate galleries and stunning natural environment. It also houses research and academic programs, including a major art history library, and is a leading international center for research and discussion on the nature of art and art history.

<u>Iroquois Indian Museum</u> in Howes Cave on Caverns Rd. The Library offers a museum pass for free admission for two adults and children under 18. The pass provides admission to the museum and the nature trail through the 45 acre Nature Park. The pass can't be used for special events or festivals.

The Old Stone Fort Museum Complex located in Schoharie also houses the Schoharie County Historical Society and Research Library. The Library offers three free museum passes for two adults and two children now through October 31. Passes can't be used for special events. Visitors learn about the first Dutch and German settlers in the Schoharie Valley and their Indian neighbors. Artifacts date back to the early 1700s.

<u>USS Slater</u> berthed on the Hudson River in Albany. The Library offers a free museum Family Pass for two adults and two children. Open for Tours: April through November. During World War II, 563 Destroyer Escorts battled Nazi U-boats on the North Atlantic protecting convoys of men and material. In the Pacific they stood in line to defend naval task forces from Japanese submarines and Kamikaze air attacks. The American Legion Clarke White Post #589 provided the support to obtain the pass.

#### Something is Missing

Have you noticed those cream and green historical markers signs have been disappearing throughout the town? No, we don't have a sign thief or teenage pranksters. Two of the Rensselaerville Historical Society Trustees have been spending their Sunday afternoons oiling and heating up rusted screws so the signs can carefully be lifted off their poles and moved to the Grist Mill in Rensselaerville. These signs have been placed in the town over the years by the Rensselaerville Historical Society at various locations with the help of the Rensselaerville Town Highways employees. Maybe you have noticed that many of these signs have become rusty and faded. Mount Pisgah, Rensselaerville Academy, Potters Hollow, Cooksburg and Preston Hollow signs are down. Soon to be removed are the two in Medusa, town building and Peckham Hollow. There may be a few other signs still in our town that haven't been located but by winter all should safely be under shelter.

The first steps to refurbish them will be to remove the rust and prime them before the oil base paint can be applied. Many of the support brackets are cracked and a solution to repairing them needs to be found. Four Greenville Central School seniors have volunteered to undertake this project under the guidance of Tony Campo and Matt Mulholland and will earn them Community Service credit. The goal was to work on the signs during Sundays in October but the weather has not cooperated. An attempt to get as much of this project done this fall is planned and the rest will have to wait for warmer weather. Look for the signs to reappear in late spring with an easier to read colors. If any individual or group would like to tackle the New York State Historical signs, the blue and gold ones, many of them need a face lift too. Let's make our town's history shine for future residents.

Other news – Two new Board of Trustees members were voted in at the Historical Society's Annual Meeting in August. The new members are Thomas Synder of Medusa and Linda Mormile of Potters Hollow and reelected was Garrett Platell. Officers were also elected for a two year term the new President is Matthew Mulholland, Vice President Kenneth Storms, Treasurer Leah Waldron, Secretary Joyce Chase and Membership Secretary Diana Fritz. The guest speaker at the annual meeting was Jerry Finin who shared photos and the process he went through to write the biography about Doctor Anna Ward Perkins the hilltown Doctor that treated patients throughout our town from 1928 until the 1990's. Over 80 guests shared a pot luck dinner and the fascinating talk.
